Preamble

I. Purpose of the contract

The Sponsor shall provide the Organizer with financial resources to implement the event specified in the preamble.

In return, the Organizer undertakes to mention the Sponsor in an appropriate promotional manner.

The following contract text defines the primary contractual services in more detail.

II. Scope of services

III. Rights and Obligations of the Organizer

The details of the sponsor packages defined in point II are the sole responsibility of the organizer, if not agreed differently in point II.

However, the Organizer complies with the Sponsor's justified requests for changes without delay.

IV. Provision and financing of advertising media

The Sponsor undertakes to provide the Organizer with the materials, signs, logos, etc., necessary for the advertising measures agreed in point II. These advertising media may only be used for the purpose specified in this Agreement and are to be returned at the Sponsor's expense after the Agreement's termination.



V. Transfer of rights

The Contracting Parties expressly state that the provision of the advertising material does not transfer any rights of any kind whatsoever to the Sponsor's products, names, or intellectual property rights.

VI. Advertising success

The organizer assumes no liability for a specific number of visitors to the sponsored event or for achieving a particular level of advertising success.

VII. Force majeure

If the event does not take place due to force majeure or for any other reason for which the organizer is responsible, the organizer is obliged to refund the amount specified in point II.

VIII. Termination of the Agreement

This Agreement shall terminate upon termination of the Sponsored Event without the need for termination.

IX. Written Documents

This agreement conclusively regulates the legal relations between the contracting parties. Agreements concluded before or at the time of this contract's conclusion shall lose their validity upon its signing.

Ancillary agreements made after the conclusion of this contract must be made in writing to be effective.

X. Applicable law

This contract – including the question of its validity – is governed by Austrian law.
